**JUAB COUNTY BOARD OF HEALTH APPROVAL**

**FEE**

The fee for each license to hold an event upon county roads is one hundred dollars (\$100) for each day of the event.

**INSURANCE**

Prior to the issuance of a license, the applicant shall obtain event insurance, either through Juab County or through a private insurance carrier, which names Juab County as a co-insured and shall provide Juab County with a certificate of said insurance.

**REVOCATION**

**DEFINITIONS**

**Event:** means an organized activity which would disrupt the flow of traffic upon a county road, such as a race, procession, parade, etc. by any means including, but not limited to, bicycling, running or any motorized or mechanical means.

**County Road:** means all public roads and streets within the county not designated as State Highways which are situated outside of incorporated cities and towns and such roads and streets situated within incorporated cities and towns that have been designated as county roads and those public roads located within national forest and constructed or maintained by the county under agreement with the appropriate federal agency.
